## CERTIFICATE

I, PAUL KATZ, Marchand, Commissioner authorized to take oaths under the Naturalization Act and amendments, do certify that Abram Victor an alien, formerly of Berlad Prov of Moldavia Roumania and now of the City and district of Montreal, P. Q., in Canada, Merchant residing at No. 1083 St Lawrence St aged 28 on the 20th day of November 1906 subscribed and took, before me, the oaths of residence and allegiance authorized by the eight section of "The Naturalization Act" and therein swore to a residence in Canada of 7 years: that I have reason to believe, and I do believe, that the said Abram Victor within the period of 7 years preceding the said day, has been a resident within Canada, for 7 years, that the said Abram Victor is a person of good character, and that there exists, to my knowledge, no reason why the said Abram Victor should not be granted all the rights and capacities of a natural-born British subject.

## OATH OF ALLEGIANCE.

do sincerely promise and swear that I will be faithful and bear true allegiance to His Majesty King Edward VII, as lawful Sovereign of the United Kingdom of Great Britain and Ireland, and of the Dominion of Canada depending on and belonging to the said Kingdom, and that I will defend Him to the utmost of my power against all traitorous conspiracies or attempts whatsoever which shall be made against His Person, Crown and Dignity and that I will do my utmost endeavor to disclose and make known to His Majesty, His Heirs, or Successors, all treasons or traitorous conspiracies and attempts which I shall know to be against him or any of them; and all this I do swear without any equivocation, mental evasion or secret reservation  
So help me God.

WHEREFORE your Petitioner prays that he be naturalized a British Subject, and that all the rights and capacities of a Natural born British Subject, be granted to him, and that a certificate of Naturalization, showing that your Petitioner has complied with all the requirements of law, be issued.
